## Partnering to Reduce the Burden for the Most Vulnerable New Mexicans

New Mexico Gas Company recognizes our responsibility to operate in a manner benefitting all our customers, including those most impacted by their energy burden (or the portion of their gross household income spent on energy costs). To support our state's most vulnerable communities, New Mexico Gas Company has partnered with the New Mexico Mortgage Finance Authority (MFA) and EnergyWorks and has developed various Energy Efficiency programs. These programs offer weatherization services to qualifying customers to help make their homes more energy efficient, help reduce their energy use, and to help save money on utility bills – at no cost to the customer.

## Here are some of our Energy Efficiency programs for income-qualified customers:

## Community Energy Efficiency Program

This program supports the efforts of community organizations working to reduce the energy burden of income-qualified customers, leveraging funds and grants to maximize the help we can offer. The program provides no-cost natural gas energy efficiency services to help residents save energy and money.



## Energy\$mart Program

As part of the U.S. Department of Energy's Weatherization Assistance Program, since 2009 we have partnered with MFA to help income-qualified residents save money on utility bills by making their homes more energy efficient. Homeowners and renters who qualify may receive up to \$6,000 in weatherization services.

### Native American Energy Efficiency Program

Working with housing authorities and tribal leaders, this program has provided free weatherization services to over 400 customers across 10 tribal communities throughout our state.

## MANUFACTURED HOMES COMMUNITY ENERGY EFFICIENCY PROGRAM

Colder weather may prompt people to increase the set temperature of their water heater. Hot water is the leading cause of scald burns and admissions to hospital burn units. It is recommended by the U.S. Department of Energy to set the temperature on your water heater thermostat to 120 degrees Fahrenheit. This setting also uses less natural gas and helps you save money.
