ORDER SETTING FILING DATE FOR REVISED APPLICATION

THESE MATTERS come before the Hearing Examiners upon various pleadings filed with the New Mexico Public Regulation Commission ("NMPRC or Commission") and emails sent from the parties regarding proposed schedules for this case. Being fully advised in the premises, the Hearing Examiners FIND and CONCLUDE that:

- 1. In the Order Vacating Prehearing and Hearing Dates issued on June 12, 2025, the recent procedural history for this case was set forth and will not be repeated here.
- 2. On June 12, 2025, Western Resource Advocates ("WRA") emailed partes with their witnesses' hearing unavailability dates.
- 3. On June 13, 2025, the New Mexico Public Regulation Commission ("Staff"), the New Mexico Department of Justice ("NMDOJ"), New Energy Economy ("NEE"), Western Resource Advocates ("WRA"), the Coalition for Clean Affordable Energy ("CCAE") and the New Mexico Affordable Reliable Energy Alliance ("NM AREA") (hereafter "Joint Movants"), ¹ emailed their proposed schedule for this case.

- 4. On June 13, 2025, Counsel for New Mexico Gas Company ("NMGC"), after having an opportunity for discussion with the other parties, emailed on behalf of the Joint Applicants, a revised proposed schedule that set out further proposed procedural dates, including filing a revised application filing deadline of July 3, 2025.
- 5. On June 18, 2025, the Coalition for Clean Affordable Energy ("CCAE") filed a Notice of Unavailability of Counsel that indicated that due to prior hearings set before the New Mexico Environmental Improvement Board, Counsel was unavailable for hearings on September 22-26, 2025; September 29 October 3, 2025; and, November 17-21, 2025.
- 6. On June 26, 2025, the NMPRC issued an Order Granting Interlocutory Appeal that granted Bernhard Capital Partners' ("BCP Applicants") April 7, 2025, Interlocutory Appeal. The Commission Order reversed the Order Denying BCP Applicants' Motion for Confidentiality finding that the claimed information² should be treated as confidential "and all parties who have received any such information in the course of this docket shall maintain the confidence of such information."
- 7. There are no further appeals before the Commission. The Hearing Examiners note that while the parties were unable to reach an agreement on a proposed schedule, Joint Applicants did propose deadlines closer to those of Joint Movants than originally proposed. The Hearing Examiners find that the following procedural details shall be completed prior to the issuance of
